

Nevertheless, having said that, it should help many to appreciate they are not alone; that others have and are going through similar difficulties; that there is hope; that there is escape if they truly work toward it. Throughout, â ^triggersâ ™ are described and talked about but we must bear in mind these are also personal to her. For others the â ^triggersâ ™ may be very different. Catherine (if I may be so personal as to refer to her by first name) frequently explains how, through her dysfunctional family, she consistently felt valueless.
